SSP was established to provide scholarships and mentoring to students in South Africa who were former victims of apartheid

SSp currently utilizes local South African not-for profit organizations which are better equipped to carry out its purpose described above. SSP relies on these organizations for the selection of students for scholarships, the provision and supervision of mentors for these students, as well as for the general supervision of the local programs

The requirements that an organization must meet in order to receive a benefit from SSP are as follows

- a It must be organized as a not for profit organization
- b It must be located in South Africa
- c It must provide scholarships to needy students in South Africa
- d It must provide mentors to students
- e It must monitor the progress of the students and address any address any students who fail to maintain passing grades, and
- f It must be able and willing to provide SSP with audited financial statements on an annual basis indicated how SSP's grants were expended
