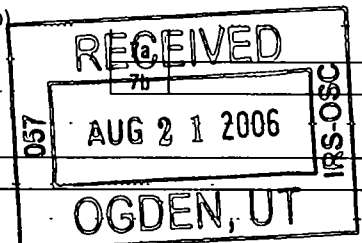

THE FOUNDATION, THROUGH PARTNER HOSPITAL REFERRALS, PROVIDES FINANCIAL ASSISTANCE TO CHILDREN WITH CANCER WHO ARE IN MEDICAL AND FINANCIAL CRISIS. JJCCF RAISES AND GRANTS FUNDS FOR THE NECESSARY TREATMENT AND CARE OF FINANCIALLY CHALLENGED CHILDREN WITH CANCER. A CHILD DIAGNOSED WITH CANCER TODAY HAS A 70% CHANCE OF BEING ALIVE AND WELL YEARS FROM NOW.
