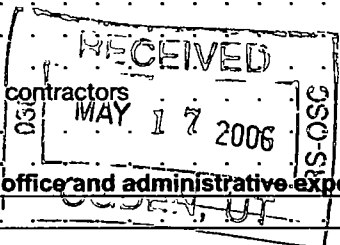

Part III – Statement of Program Service Accomplishments

The primary exempt purpose of the Lubuto Library Project is to provide an opportunity for an informal education to orphans and vulnerable children in Sub-Saharan Africa, thereby improving literacy, language skills, general knowledge and participation in society. This will be done initially through two program services: (1) the establishment of libraries (buildings and collections) for orphans, street kids and other vulnerable children, particularly those affected by HIV/AIDS, in Africa; and (2) the raising of awareness of the issue in young Americans through an educational and book drive program to be conducted in schools. A third program service, working with staffs of the libraries to develop ancillary literacy, arts and enrichment programs, including a local cultural preservation and bookmaking program, will begin after libraries are up and running.

Significant achievements for each program service include the following:

- ***Establishment of Libraries:*** A regional office of the Lubuto project was established in Lusaka, Zambia and officially registered with the Government of Zambia on September 21, 2005. Meetings with Government officials and potential host organizations have been carried out, and a host for the first library was identified. Architectural and construction plans were developed for that site. In Washington, DC and in Zambia, extensive efforts were carried out to identify funds for the construction. A fundraising event at the Zambian Embassy in Washington yielded \$16,000 of donations.
- ***Book Donation and Awareness Program:*** Book drives and educational programs were carried out, as pilots, at two schools in Maryland and DC. Approximately 5000 donated books were collected. Filming for an educational video, to be used in U.S. schools, was completed with the help of middle school students.
- ***Ongoing Training and Ancillary Enrichment Program:*** This program service includes the creation of books by the children served in the libraries, as described in the project's Form 1023. This project service will begin after the first library has been constructed
