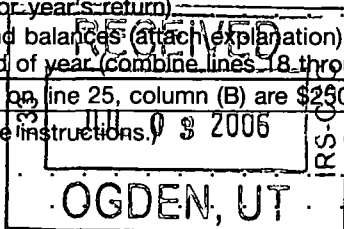



After a thorough review of the accounting for Global Justice Ecology Project for fiscal years 2004 and 2003 some minor accounting errors were identified which changed our fund balances at the end of the year.

Our FY 2003 End of year balance was recorded on our 990-EZ as \$1,735.19. It was actually \$1,731.70. This is a net change of -\$3.49

Our FY 2004 End of year balance was recorded on our 990-EZ as \$3,884.71. It was actually \$3,975.85. This is a net change of +\$91.14.

The combination of these two errors requires an adjustment of +\$87.65 to reconcile our 2005 tax return. This amount is therefore recorded on Part I, line 20.
