Statement 2 - Form 990, Part III, Line a - Statement of Program Service Accomplishments

Georgia's Gwinnett County has a waste water allocation "request for permit" pending before Georgia's Environmental Protection Division (EPD). The county proposed dumping an additional 40 million gallons of treated sewage per day into Lake Lanier. To protect water quality, the Lake Lanier Association (LLA) retained the services of attorneys and professional engineers to evaluate the water quality standards set by the EPD and to assist in the battle against this threat to Lake Lanier. As a result of these actions and the efforts of LLA members, the EPD revised its standards to include the improvements recommended and changed certain parameters to protect Lake Lanier. This effort has now moved to legal battles against the county's efforts to get approval through other methods. After the Administrative Law Judge ruled in the EPD/Gwinnett's favor, LLA initiated efforts and fundraising to appeal this decision in late 2002. This effort continued into 2003.

Statement 3 - Form 990, Part III, Line b - Statement of Program Service Accomplishments

For the fifteenth consecutive year, LLA planned a lake-wide clean up day called "Shore Sweep". This event typically involves 1,000 volunteers who collect an average of 20 tons of trash, household refuse, styrofoam and other debris from the lake and its shores. Another organization wished to combine efforts for a joint clean up, and the LLA withdrew from the planning due to the commercial aspects of this group and instead concentrated its efforts on planning the event for Spring 2003.

Statement 4 - Form 990, Part III, Line c - Statement of Program Service Accomplishments

LLA sponsors a water testing program called "Adopt a Lake". Volunteer members of the association regularly take water samples from the lake and submit them to an independent laboratory for testing. The data is then used to monitor the water quality of the lake and is placed on the association's Lake Watch Report on the website. Volunteers undergo a certification process in conjunction with Gainesville College. The volunteers are divided into three lake zones based upon the lake hydrology (riverine, interzone and lacustrine). Each zone has a volunteer manager and co-manager who coordinate the participants' efforts, data input, back up testing and taking samples to the lab.

Through newsletters, press releases, website, membership meetings and advocacy programs, promoted and enhanced public awareness of the significant natural, social and economic values of Lake Sidney Lanier and functioned as a clearing house for information, to educate all interested and responsible parties in improved stewardship of the lake. LLA promoted volunteer citizen action to monitor, educate and advocate for improved protection of Lake Sidney Lanier.
