


PROTECT CHILDREN IN TOURISM (PCT) PROJECT

WITH FUNDING FROM THE BODY SHOP FOUNDATION AND THE U.S. DEPARTMENT OF STATE, THE PCT PROJECT INTRODUCED THE CODE OF CONDUCT FOR THE PROTECTION OF CHILDREN FROM SEXUAL EXPLOITATION IN TRAVEL AND TOURISM IN NEW PLACES IN THE RIVIERA MAYA SECTION OF MEXICO. A CODE OF CONDUCT KICK OFF EVENT WAS HELD IN PLAYA DEL CARMEN AND ANOTHER IN COZUMEL, TWO IMPORTANT RESORT DESTINATIONS. IN BOTH PLACES ALL THE IMPORTANT TRAVEL, TAXI AND GOVERNMENT ASSOCIATIONS JOINED THE EFFORT BY SIGNING THE CODE OF CONDUCT, PROMOTING IT PUBLICLY AND ATTENDING TRAININGS. FOUR TRAININGS HAVE BEEN HELD IN PLAYA DEL CARMEN AND ONE IN COZUMEL, WITH HUNDREDS OF INDUSTRY PERSONNEL TRAINED ABOUT THE CODE OF CONDUCT, THE LAWS AGAINST CHILD SEX TOURISM AND WHAT TO DO WHEN IT IS IDENTIFIED.

IN BELIZE, THE PCT PROJECT HAS STARTED WORKING WITH THE BELIZE TOURISM INDUSTRY ASSOCIATION (BTIA) AND THE BELIZE NATIONAL ORGANIZATION FOR THE PREVENTION OF CHILD ABUSE AND NEGLECT (NOPCAN) EXPAND THE CODE OF CONDUCT, TRAIN TRAVEL INDUSTRY PERSONNEL AND MONITOR COMPLIANCE WITH THE CODE OF CONDUCT.

IN THE UNITED STATES, ECPAT-USA LAUNCHED A LETTER WRITING CAMPAIGN ASKING US HOTELS TO SIGN THE CODE OF CONDUCT. WORKING WITH RESPONSIBLE INVESTOR GROUPS WHO USE SHAREHOLDER RESOLUTIONS TO GET TRAVEL COMPANIES TO THE TABLE, THERE HAVE BEEN DISCUSSIONS WITH SOME LARGE HOTEL CHAINS AND AIRLINES ABOUT SIGNING THE CODE OF CONDUCT.

ECPAT-USA YOUTH

THE ECPAT-USA YOUTH COMMITTEE CONSISTS OF NEW YORK CITY HIGH SCHOOL STUDENT WHO ARE LEARNING ABOUT AND TEACHING OTHERS ABOUT THE COMMERCIAL SEXUAL EXPLOITATION OF CHILDREN AND CHILDREN'S RIGHTS. THEY CONDUCTED A SURVEY OF THEIR PEERS TO LEARN THE LEVEL OF KNOWLEDGE BY YOUTH ABOUT THEIR RIGHTS. THE RESULTS OF THE SURVEY WERE INCLUDED IN THE ALTERNATIVE REPORT TO THE UN COMMITTEE ON THE RIGHTS OF THE CHILD (SEE BELOW).

THE YOUTH COMMITTEE DESIGNED AND CREATED A MURAL TO BE USED FOR PUBLIC EDUCATION AND THEY ARE CURRENTLY WORKING ON ANOTHER ONE. THEY CONDUCTED OUTREACH IN NEW YORK CITY'S UNION SQUARE TO TALK ABOUT CHILD SEX TRAFFICKING AND SEX TOURISM. AS PART OF THE PROJECT THEY ASKED THE PUBLIC TO SIGN POSTCARDS CALLING ON US HOTEL CHAINS TO SIGN THE CODE OF CONDUCT. THEY CURRENTLY ARE DESIGNING AND CREATING A SECOND PUBLIC EDUCATION MURAL THAT WILL CALL ATTENTION TO THE PROBLEM OF AMERICAN CHILDREN TRAFFICKED FOR SEXUAL EXPLOITATION. IT WILL BE USED AS PART OF A PUBLIC OUTREACH CAMPAIGN TO PASS LEGISLATION IN NEW YORK STATE TO PROTECT CHILDREN FROM SEXUAL EXPLOITATION.

THE INTERNATIONAL SECRETARIAT FOR THE CODE OF CONDUCT FOR THE PROTECTION OF CHILDREN FROM SEXUAL EXPLOITATION IN TRAVEL AND TOURISM IS HOUSED AT ECPAT-USA AND SUPPORTED BY IT.

ALTERNATIVE REPORT

IN MAY 2007 THE U.S. GOVERNMENT SUBMITTED A REPORT TO THE UN COMMITTEE ON THE RIGHTS OF THE CHILD ABOUT ITS IMPLEMENTATION OF THE OPTIONAL PROTOCOL TO THE UN CONVENTION ON THE RIGHTS OF THE CHILD ON THE SALE OF CHILDREN, CHILD PROSTITUTION AND CHILD PORNOGRAPHY. ECPAT-USA CONVENED A MEETING OF NGOS TO PREPARE AN ALTERNATIVE REPORT TO THE US REPORT. THE REPORT WAS JOINTLY PREPARED BY A NUMBER OF US NGOS AND SUBMITTED TO THE UN COMMITTEE IN NOVEMBER, WITH ABOUT 35 NGOS JOINING ECPAT-USA AS SUBMITTING ORGANIZATIONS. IN FEBRUARY WE MET WITH THE UN COMMITTEE TO DISCUSS THE US REPORT AND THE ALTERNATIVE REPORT.

HUMAN TRAFFICKING OUTREACH

ECPAT-USA CONDUCTS OUTREACH INTO ETHNIC COMMUNITIES ABOUT HOW TO IDENTIFY TRAFFICKING VICTIMS AND REFER THEM FOR SERVICES WHEN IDENTIFIED. THIS WORK HAS BECOME INCREASINGLY DIFFICULT IN THE U.S. BECAUSE OF AN ANTI-IMMIGRANT POLITICAL AND SOCIAL ENVIRONMENT IN THE COUNTRY. NONETHELESS, UNDERTAKES FREQUENT SPEAKING, TRAINING AND OTHER AWARENESS RAISING ACTIVITIES WITH MANY ASSOCIATIONS, SCHOOL AND CHURCH GROUPS AND PROFESSIONAL AND WOMEN'S ORGANIZATIONS, IN NEW YORK CITY AND AROUND THE COUNTRY.

PUBLIC AWARENESS RAISING

A LARGE PART OF ECPAT-USA'S WORK IS RAISING AWARENESS ABOUT CHILD SEXUAL EXPLOITATION, SEX TOURISM AND TRAFFICKING.
