Through advocacy, education and diverse partnerships, we advance renewable energy and energy efficiency.</p> <p>All organizations must describe their exempt purpose achievements in a clear and concise manner. <p>a In 2007, our program activities included CLIMATE CHANGE CAMPAIGN - Utah Clean Energy served on Governor Huntsman's Blue Ribbon Advisory Council on Climate Change (BRACC), the Utah Department of Environmental Quality Climate Change Work Group, the Renewable Energy Initiative Group, and relevant sub-work groups and subcommittees. Our clean energy advocacy work helped shape Utah's climate reduction strategies and educate stakeholders to gain broad support of these strategies. COMMUNITY CLEAN ENERGY CAMPAIGN - Utah Clean Energy provided consultation and support on energy policy and program development to the following communities in Utah: Logan, Ogden, Cedar Hills, Daybreak, Alta, Moab, Park City, Salt Lake City, and Salt Lake County. In 2007, Park City and Alta were designated as U.S. Environmental Protection Agency Green Power Communities and Cedar Hills became an EPA Green Power Partner. We also provided information to thousands of Utah residents, businesses, congregations, and community groups on renewable energy and energy efficiency. ENERGY EFFICIENCY STRATEGY - Utah Clean Energy worked closely with Governor Huntsman's Office and Southwest Energy Efficiency Project to develop a state strategy to achieve Utah's 20% energy efficiency goal. The strategy lays out a pathway that achieves the efficiency goal while yielding over \$7 billion in net economic benefits to the state of Utah. GREEN POWER PURCHASING PROGRAMS - Utah Clean Energy promoted participation in voluntary green power purchasing programs, such as Rocky Mountain Power's Blue Sky Program. As a result of our outreach, over 21,500 Utahns and 500 businesses are participating in these programs - representing 100,812 megawatt-hours, which is equivalent to the electricity used by 10,000 average Utah homes for one year. POLICY OUTREACH - Utah Clean Energy participates in Utah's energy-related policy efforts by providing technical assistance, educating the public, key stakeholders and policymakers, building coalitions, and garnering media attention. Five clean energy bills were introduced in the 2007 State of Utah Legislative Session and three bills were enacted into law. REGULATORY ADVOCACY - Utah Clean Energy participates and intervenes in Utah's utility regulatory arena, advocating for renewable energy and energy efficiency. This year, we successfully intervened in the annual review of Questar Gas's pilot conservation-enabling tariff/decoupling, a solar thermal rebate program in 2008, Questar's DSM programs, and Rocky Mountain Power's pilot utility photovoltaic rebate program. RENEWABLE ENERGY COMMUNITY PROJECTS - Utah Clean Energy provided information and technical consultation to community organizations and local governments on the Blue Sky Fund Award, a program to support new, small-scale, community based renewable energy projects in Utah, Idaho, and Wyoming. Thirteen wind and solar projects received funding through the program in 2007. SOLAR SALT LAKE PROJECT - Utah Clean Energy is partnering with Salt Lake City and Salt Lake County to develop a fully-scooped city and county-level implementation plan that will facilitate at least an additional ten megawatts of solar photovoltaic (PV) installations in government, commercial, industrial, and residential sectors by 2015. WIND OUTREACH - Utah Clean Energy is partnering with the Utah State Energy Program and the U.S. Department of Energy to develop a wind energy outreach strategy for Utah.
