


The event had 1,000 in attendance, and was covered by multiple outlets, including CNET, Forbes, SF Chronicle, SJ Mercury News and Wired. Since being founded in 2006 by Ray Kurzweil, Peter Thiel and Tyler Emerson, the Singularity Summit has become the world's leading forum in the Singularity, bringing together scientists, technologists, skeptics, and enthusiasts alike. <p>Dr. Ben Goertzel, a leading researcher in the field of AGI, joined as SIAI Director of Research. Research Fellow Eliezer Yudkowsky made two important contributions to "Global Catastrophic Risks" (Oxford University Press), "Artificial Intelligence as a Positive and Negative Factor in Global Risk" and "Cognitive Biases Potentially Affecting Judgment of Global Risks." <p>SIAI added four team members: Susan Fonseca (COO), Bruce Klein (Director of Outreach), Jonas Lamis (Director of Partnerships), and Colby Thomsom (Director of Strategy). Director of Development Allison Taguchi oversaw SIAI's largest fundraising effort to date, the 2007 Singularity Challenge, raising \$500,000 from over 200 donors. The SIAI Blog was launched, featuring original content from SIAI researchers and staff, including "Three Major Singularity Schools", "The Singularity and Singularity Institute", and "The Power of Intelligence". The SIAI Interview Series was released online, spanning 13 video interviews, including Dr. Stephen Omohundro (Self-Aware Systems), Dr. Peter Norvig (Google), and Peter Thiel (Clarium).
