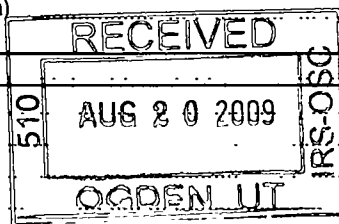



SOME OF OUR MEDIA PARTNERS INCLUDED ABC LOCAL 10 CARE FORCE, CBS NEIGHBORS 4 NEIGHBORS, SUN-SENTINEL AND THE MIAMI HERALD.
