THE VIEWERSHIP OF THE SURVIVOR/PATIENT FORUM, A REAL TIME VEHICLE FOR PATIENTS NEWLY DIAGNOSED TO TALK WITH THOSE WHO HAVE ALREADY TRAVELED THIS PATH AND WITH CAREGIVERS, CONTINUES TO BE THE HEART AND SOUL OF THE WEB SITE. OVER 3000 ACTIVE POSTERS OUT OF 6500 REGISTERED USERS (APRIL 2007) PARTICIPATE IN THE FORUMS DISCUSSIONS. PATIENTS AND SURVIVORS FROM AS FAR AWAY AS HONG KONG, AUSTRALIA, AND GREAT BRITAIN PARTICIPATE WITH THE 86% OF POSTERS WHO ORIGINATE WITHIN THE U.S. THE WEB SITE CONTINUES TO OCCUPY THE NUMBER ONE POSITION IN THE WORLD'S MOST POPULAR SEARCH ENGINE GOOGLE, (A SPOT WHICH CANNOT BE BOUGHT) AND OVER 38,500 OTHER MEDICAL AND DENTAL SITES LINK BACK TO THE CONTENT AT THE OCF SITE. AS A TESTAMENT TO THE QUALITY OF THE INFORMATION PROVIDED ON THE SITE, AFTER SEARCH ENGINES, OUR PRIMARY SOURCE OF REFERRALS AND NEW TRAFFIC COMES FROM THE NIH, THE NCI, ACS, AND OTHER WELL-RESPECTED GOVERNMENTAL, AND PROFESSIONAL MEDICAL DENTAL WEB SITES. ALL OF THE INFORMATION IN THE WEB SITE, AS WELL AS THE DISCUSSION FORUMS, IS PROVIDED AT NO CHARGE TO ANYONE WHO WISHES TO ACCESS THEM VIA THE WORLD WIDE WEB.
