The purpose of the Solid Ground Supportive Housing Program is to provide homeless and at-risk youth with an opportunity to create a meaningful and positive future for themselves.













The Crisis Center Program provides free, accessible, bilingual and bicultural case management, housing advocacy, and job training and placement services to families, youth and single individuals who are homeless or are at risk of becoming homeless. Crisis Center staff work in partnership with clients to obtain and maintain housing and employment stability. Since opening its doors in July of 2002, the Crisis Center has served over 2,100 households.
