A WRITTEN RECORD OF ANY REPORT OF POSSIBLE CONFLICT AND OF ANY ADJUSTMENT MADE TO AVOID POSSIBLE CONFLICTS OF INTERESTS SHALL BE KEPT BY THE PRESIDENT & CEO OR, WHERE APPLICABLE, CHAIR.
