St John's Well Child and Family Center is a 501(3)non-profit organization that serves as a primary source of health care for more than 100,000 poor and low-income residents of downtown and Los Angeles St John's operates eleven clinics in south Los Angeles, the most densely populated neighborhood in southern California with close to 1 million people As a "center of community health" St John's provides medical, dental and mental health services, case management, health education, and social support The clinics include five comprehensive community health centers and six school based clinics reaching from downtown to South Central Los Angeles to Compton In addition, St John's operates many community health, social service and school readiness programs These programs are designed to improve birth outcomes and reduce high-risk pregnancies and improve readiness for school among preschool children and their families St John's also provides child care and early childhood development services, parenting workshops, workforce readiness trainings and parent/child literacy projects
