SUPPORTIVE HOUSING -Hearth manages seven supportive housing sites for 137 formerly homeless elders and those who were at risk of homelessness. All of Hearth's residents receive the help they need to stay safely housed, and over 75 residents or just over one-half of Hearth's resident population receives daily assistance in order to remain housed in the community.

OUTREACH -Four case managers and a Director assisted approximately 250 homeless elders in their search for permanent housing and services during the year. Of the total served in 2009, 57 homeless elders were placed in permanent housing. Additionally, of the elders placed in permanent housing in the previous year, approximately 97% were still housed -- a success rate of which we are very proud.
