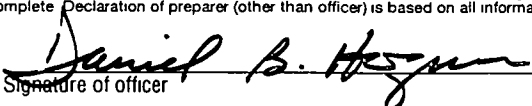
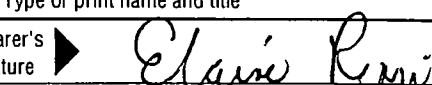

Cultivation, preservation and performance of folk music in an historic folk art coffee house known as "Club Passim".

Club Passim put on 407 concerts in 2009 for an audience of 32,511. In addition to our regular concerts, we held a variety of special concerts, including a regular open mic series, bimonthly Poets Theatre, monthly Celtic Music Festival, and a "Veritas" evening for Harvard University students to perform. We help develop young artists by being willing to have them perform to smaller audiences and having them open for better-known musicians.

School for folk music for all levels and workshops.

The Passim School of Music offers students of all levels a number of ways to learn. Students study in classes, private and semi-private lessons, workshops and master classes. The curriculum is specially designed to provide not only expert instruction, but also a supportive community of fellow students and instructors.

The School of Music consists of 5 terms of 6 weeks each from September through June. In general, classes meet once a week for one hour and fifteen minutes. Classes range from 5-12 students. Courses range from beginning to advanced guitar, songwriting, banjo and fiddle. In 2009, there were 505 students taking 59 classes and 17 workshops.

Outreach Program

The Passim Folk Music and Cultural Center maintains a strong presence in the Cambridge community throughout the year. Passim marks the arrival of spring with a music stage at Harvard Square's Mayfair festival. The Passim stage highlights a range of genres, from bluegrass to singer-songwriter to the bluesy Americana of Tim Gearan. The 2009 Mayfair stage featured Chris O'Brien, Mieka Pauley, Anne Heaton, the David Wax Museum, and Margaret Glaspy.

In honor of the summer solstice on June 21, Passim transforms Palmer Street into a kids' musical festival as part of Make Music Cambridge. Passim musicians play children's songs throughout the day while kids create their own maracas and tambourines. At the instrument petting

During the summer, Passim presents a weekly concert series at Cambridge Center in Kendall Square. Every Wednesday, students, businesspeople, and local residents come together at lunchtime to enjoy the music of artists like Sarah Borges, Chad Perrone, and Amber Rubarth. Passim presents the series in collaboration with Boston Properties, Marriott, and the Cambridge Redevelopment Authority.

Passim also provides a music stage at Oktoberfest every Columbus Day and presents established artists, including Anne Heaton and Meg Hutchinson, as well as other up and coming local musicians. The 2009 Passim Oktoberfest stage featured performances by Rose Polenzani, Rebecca Wudarski & Mia Friedman, Lake Street Dive, Emily Elbert, Margaret Glaspy, and the Broken Blossoms.

Passim often collaborates with the Harvard Square Business Association and the Harvard Coop to provide music for their events in Harvard Square. In June of 2009, the Passim stage at the Taste of Cambridge featured the music of the Sweet and Lowdown.

In addition to its outreach events around the city, Passim also opens its doors to the Cambridge community for celebrations, book release parties, and other special events.
