**4a** (Code ) (Expenses \$ 217,302 including grants of \$ ) (Revenue \$ )  
 Publishing - In February of 2009, we completed the seventh annual Young Authors' Book Project, our largest publishing project of the year. The Young Authors' Book Project is professionally published and distributed nation-wide. We partnered with Pirette McKamey's eleventh and twelfth graders at Mission High School to create Show of Hands: Young Authors Reflect on the Golden Rule. Fifty-four Mission High students worked with tutors for four months as they wrote, edited, and designed the book. Local author Joe Loya met with students early in the process, and later he wrote the introduction to the book. We celebrated the release of Show of Hands with a party at the Women's Building just around the corner from 826 Valencia, where families, teachers, tutors, and friends gathered to hear students read from their essays. In our Writers' Room at Everett Middle School, students worked on the bilingual newspaper Straight-Up News for the sixth year running. Last spring, these student reporters had the chance to meet San Francisco Giants players and write for the Giants Magazine in addition to the SUN. In addition to the above projects, we published chapbooks, bilingual journals in Spanish and English, and literary magazines to make a total of 166 publications of student writing.

**4b** (Code ) (Expenses \$ 102,356 including grants of \$ ) (Revenue \$ )  
 In-schools - Our first full school year of running programs in our second Writers' Room at James Lick Middle School was a huge success. We established a constant presence in the school, and we worked on projects ranging from science fair speeches to Spanish-language poetry. We also established a cornerstone project with the eighth grade video class: the James Lick Video Podcast Series. At other schools in San Francisco, we maintained a strong volunteer presence throughout the school year. We visited fifteen different schools, with 276 tutors, to support teachers on various writing projects. We continued to actively solicit feedback from the teachers with whom we collaborate and all of their students. At the end of every in-schools project, each teacher and student fills out an evaluation form, which helps us to understand what impact the projects had on their students. One hundred percent of teachers with whom we worked this past year felt that their students were engaged in and challenged by their 826 Valencia in-schools project.

**4c** (Code ) (Expenses \$ 90,862 including grants of \$ ) (Revenue \$ )  
 After-school tutoring - For the seventh year of after-school tutoring, our longest running program, we aspired to celebrate more publicly the successes of the students involved. In February 2009, for a crowd of families and tutors, we unveiled a new exhibit to honor our most dedicated writers in the after-school program. The Young Writers' Wall features the work and photographs of six young authors, displayed prominently in the writing lab. We now change the exhibit twice a year. We also celebrated the writing achievements of our after-school tutoring students through a variety of publishing projects. We published two more volumes of our biannual after-school tutoring anthology, Look Closer, or Mira de Cerca, produced in both English and Spanish so that all students could share them with their families. The largest project the after-school students worked on was Thanks and Have Fun Running the Country: Kids' Letters to Obama, a collection of letters from across the nation that was featured in the op-ed pages of the New York Times, on the nationally-syndicated radio program This American Life, and on the front page of The San Francisco Chronicle, among other news sources.
