The Providence Animal Rescue League provided comprehensive care, medical services and adoption services to 2122 animals in 2009. Services include medical exams, vaccinations, spay/neuter surgery, food, shelter, additional veterinary care, behavior evaluation, training and shelter enrichment programs. The League also spayed or neutered 417 community companion animals through our low cost Spay/Neuter Assistance Program. The League also serves as a key resource for current pet owners by providing answers to pet related concerns and questions. More than 23,000 calls were received at the League requesting assistance regarding pet related information. Other programs and services include mobile adoptions, micro chipping, food bank, euthanasia and cremation services

Humane Education programs were presented to 47 schools, colleges, community centers, libraries and clubs throughout Rhode Island in 2009. Over 2,500 school aged children received educational tours and workshops in 2009.
