IN 2009, ANJEC AWARDED \$145,915 IN GRANTS RANGING FROM \$1,400 TO \$10,000 TO HELP MUNICIPALITIES WITH ENVIRONMENTAL COMMISSIONS TO DEVELOP PLANNING DOCUMENTS AND STUDIES THAT PROTECT THE ENVIRONMENT. THE 26 PROJECTS FUNDED BY THIS PROGRAM HAD TO MATCH THE GRANT AMOUNT GIVEN. THEY HAD A YEAR TO PRODUCE DOCUMENTS THAT ANJEC CAN DUPLICATE TO GIVE OTHER MUNICIPALITIES EXAMPLES OF GOOD PLANNING. ANJEC'S WORKSHOPS AND CONFERENCES TRAINED OVER ONE THOUSAND PEOPLE DURING THE YEAR INCLUDING THIRTY THREE WORKSHOPS ON DIFFERENT ENVIRONMENTAL TOPICS AND ROAD SHOWS HELD AT THE REQUEST OF MUNICIPAL ENVIRONMENTAL COMMISSIONS. A TOTAL OF 210 LOCAL OFFICIALS AND ENVIRONMENTALISTS ATTENDED THE ANNUAL DAY-LONG CONFERENCE, THE ENVIRONMENTAL CONGRESS, ON OCTOBER 17, 2009.

OVER 2,500 PEOPLE DOWNLOADED ISSUES OF THE QUARTERLY MAGAZINE, THE ANJEC REPORT, AND AN EQUAL AMOUNT DOWNLOADED MANY ANJEC PUBLICATIONS AVAILABLE ON THE WEBSITE. THE AIM OF THE WEBSITE IS TO GIVE PRACTICAL INFORMATION ON THE REASONS FOR ENVIRONMENTAL PROTECTION, THE ACTIONS THAT LOCAL GOVERNMENTS CAN TAKE AND EXAMPLES OF WHAT DIFFERENT TOWNS ARE DOING.
