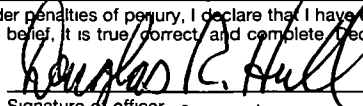

BCWA financial statements are supplied to all members annually, provided via Form 990 on the BCWA website, in the BCWA administrative office, at the annual meeting and upon request.

Form 990, Part VI.B.11a Form 990 is reviewed and approved by the BCWA Administrator and the Executive Committee (consisting of the 4 current officers plus the 2 past Presidents) before presentation to the Board of Trustees. The Board of Trustees (16 members) reviews and approves the Form 990 (by majority vote) before it is filed. A copy of the Form 990 is made available on the BCWA website and at the annual meeting for review by all members and is available upon request.

Form 990, Part VI.B.12c Beaver Creek Wetlands Association requires that each officer, trustee, employee and effected member sign a comprehensive Conflict of Interest and Gift Policy and Disclosure form annually. These documents are reviewed and accepted by the Executive Committee (consisting of the 4 current officers plus 2 most recent Past-Presidents and are retained in vital files. The Trustees and members share the responsibility of monitoring compliance with these policies with any concerns heard and addressed by the President, Vice President or any member of the Executive Committee. This process serves to provide "whistleblower" coverage for all BCWA members in lieu of a formal written "Whistleblower Policy".

Form 990, Part VI.B.15b Beaver Creek Wetlands Association employs only one person and only on a part-time basis. Compensation rate for the BCWA Administrator is established and approved by the Executive Committee, based on current market rates for comparable services and level of responsibility. The BCWA Administrator has served in this position for nearly 10 years, so his rate of compensation reflects his experience, tenure and performance. The Executive Committee reviews the Administrator compensation rate no less often than annually and adjusts accordingly as approved by unanimous consent of the Executive Committee.

2009 Form 990, Schedule D, Part II, Line 2(a)**Description of Conservation Easements Held By BCWA**

The Beaver Creek Wetlands Association, Inc. ("BCWA") holds a single conservation easement on 12.002 acres of real property located in Section 32, Town 3, Range 7, between the Miami Rivers Survey, City of Beavercreek, Greene County, State of Ohio which encompasses land with frontage on Old Mill Lane, and bordered on the south by U.S. Route 35, on the west by North Fairfield Road, on the north by Little Beaver Creek and on the east by Creekside Reserve, property of Greene County Parks. This easement was granted by Fir Peace, LLC, general partner of Pugh & Hagenbuch, a limited family partnership (1088 Old Mill Lane, Beavercreek, Ohio 45432).

The easement is designed to protect, preserve and enhance the natural, historical, residential, scenic, open space, woodland, meadow, wetland, riparian, floodplain and educational values of the land in perpetuity. The conservation easement prohibits any and all commercial uses, sub-dividing and development of the property, installation of any commercial signs, posters or billboards larger than 6 feet, construction of commercial cell or other communications towers on the property and restricts access to Creekside Reserve with certain exceptions as described in the Deed of Conservation Easement.

The Beaver Creek Wetlands Association incurred expenses of approximately \$1,000 during 2009 which included fees for documentation, legal representation, appraisal, monitoring and other miscellaneous costs related to this conservation easement.
