The organization is committed to providing a safe and nurturing environment for homeless and abandoned people, where they will benefit from a comprehensive program of education, guidance, and counseling in a community setting. La Casa Norte achieves its mission primarily through its programs: Crisis Center, Solid Ground Supportive Housing, Esperanza Trabajando and Casa Corazon.

The Solid Ground Supportive Housing Program provides safe, stable housing for homeless male youths, aged 16 to 21. These young men can stay at Solid Ground up to two years, during which time they benefit from comprehensive case management services focusing on a holistic, strength-based approach, as well as educational and vocational training and support. The purpose of the Solid Ground Supportive Housing Program is to provide homeless and at-risk youth with an opportunity to create a meaningful and positive future for themselves.

4b (Code) (Expenses \$ 399,411 including grants of \$ 66,826) (Revenue \$)

The Crisis Center Program provides free, accessible, bilingual and bicultural case management, housing advocacy, and job training and placement services to families, youth and single individuals who are homeless or are at risk of becoming homeless. Crisis Center staff work in partnership with clients to obtain and maintain housing and employment stability. Since opening its doors in July of 2002, the Crisis Center has served over 2,500 households.

The Esperanza Trabajando Program is a job readiness, training and placement program. It provides a range of job readiness services helping individuals prepare for employment. When ready for employment, the Organization's placement case manager assists program participants in finding jobs. For individuals seeking skills to assist them in crossing the digital divide, the Organization offers individuals technology training through Casa TeraU, its software training program.
