WE WORK WITH HIGHER EDUCATION AND INDUSTRY PARTNERS TO ASSIST IN THE DEVELOPMENT OF PROFESSIONAL TRAINING AND CONTINUING EDUCATION PROGRAMS TO MEET THE DEMAND FOR ENERGY EFFICIENCY AND RENEWABLE ENERGY EXPERTS. CLIMATE CHANGE CAMPAIGN - UTAH CLEAN ENERGY FACILITATED UTAH-BASED ENGAGEMENT IN THE WESTERN CLIMATE INITIATIVE PROCEEDINGS, WHICH HELPED TO INFLUENCE THEIR CAP AND TRADE DESIGN PRINCIPLES. PARTICIPATING UTAH STAKEHOLDERS INCLUDED LOCAL GOVERNMENTS OF SALT LAKE COUNTY, SALT LAKE CITY, AND PARK CITY AND OVER 30 UTAH BUSINESSES, UNIVERSITIES, AND ORGANIZATIONS. ECONOMIC DEVELOPMENT STUDY - AT THE REQUEST OF GOVERNOR HUNTSMAN'S OFFICE, UTAH CLEAN ENERGY DEVELOPED AN IN-DEPTH REPORT, "UTAH ECONOMIC DEVELOPMENT STUDY: SCENARIOS FOR RENEWABLE ENERGY AND ENERGY EFFICIENCY DEVELOPMENT IN THE ELECTRICITY SECTOR." THIS STUDY ANALYZES THE ECONOMIC DEVELOPMENT OPPORTUNITIES FOR UTAH'S ECONOMY RESULTING FROM INCREASED INVESTMENTS IN ENERGY EFFICIENCY AND RENEWABLE ENERGY IN THE STATE OF UTAH. POLICY OUTREACH - WE PARTICIPATE IN UTAH'S ENERGY-RELATED POLICY EFFORTS BY PROVIDING TECHNICAL ASSISTANCE, EDUCATING THE PUBLIC, KEY STAKEHOLDERS AND POLICYMAKERS, BUILDING COALITIONS, AND GARNERING MEDIA ATTENTION. SEVERAL CLEAN ENERGY BILLS WERE INTRODUCED IN THE 2009 STATE OF UTAH LEGISLATIVE SESSION AND FIVE BILLS WERE ENACTED INTO LAW. IN 2009, ROCKY MOUNTAIN POWER (RMP) INCREASED THEIR ENERGY EFFICIENCY EXPENDITURES FROM 36 MILLION TO 60 MILLION FOR A SAVINGS OF OVER 229,000 MWH. QUESTAR GAS ALSO SIGNIFICANTLY INCREASED SPENDING FROM 18 MILLION IN 2008 TO OVER 47 MILLION IN 2009, PREVENTING OVER 52,000 TONS OF CO2 EMISSIONS EACH YEAR. RENEWABLE ENERGY ZONE TASKFORCE - UTAH CLEAN ENERGY SERVES ON GOVERNOR HERBERT'S RENEWABLE ENERGY ZONE TASKFORCE. PHASE 1 OF THIS TASKFORCE FOCUSED ON IDENTIFYING THE CAPACITY AND GEOGRAPHICAL LOCATIONS OF RENEWABLE RESOURCES IN UTAH. PHASE 2 FOCUSES ON TRANSMISSION, POLICY, AND ECONOMIC ANALYSIS. SOLAR SALT LAKE PROJECT - UTAH CLEAN ENERGY IS PARTNERING WITH SALT LAKE CITY, SALT LAKE COUNTY, AND OTHER STAKEHOLDERS TO DEVELOP A FULLY-SCOPED CITY AND COUNTY-LEVEL IMPLEMENTATION PLAN TO FACILITATE AT LEAST 10 MEGAWATTS (OR AN ADDITIONAL 10,000 SOLAR PV SYSTEMS) OF NEW SOLAR PHOTOVOLTAIC (PV) INSTALLATIONS IN THE GOVERNMENT, COMMERCIAL, INDUSTRIAL, AND RESIDENTIAL SECTORS BY 2015.
