Exhibition Programs: The Contemporary, a non-collecting institution, presents exhibitions in a wide variety of contemporary artistic styles and media, created by diverse national & international artists. Three exhibitions in the Main Galleries, featuring two artists each, were presented in FY2009. In addition, forty artists were presented in The Front Room, which offers short projects at an accelerated pace. The Contemporary supports talented St. Louis artists through a permanent Contemporary Flat Files program, and an annual City-Wide Open Studios program. In FY2009, 122 artists participated in the City-Wide Open Studios. Total FY2009 attendance at Contemporary was 31,153.

Adult Education Programs: The Contemporary presents a diverse lineup of public education programming including artist talks, lectures, performances and workshops to improve visitor learning & enjoyment of contemporary art. The Susan Sherman Distinguished Speaker Series is designed to bring scholarship and art commentary of the highest caliber to St. Louis. In FY2009, the Contemporary welcomed Robert Storr, an internationally renowned curator, critic, academic, and artist. 272 people attended the lecture. The Contemporary's Education Resource Center offers visitors a comfortable place to learn something new about contemporary art by perusing a range of art books, periodicals, videos, and archives of past tours and lectures. Recorded podcast tours feature interviews with artists, curators, and collectors, exhibit reviews, as well as tours and staff picks.

Youth Education Programs: The Contemporary demonstrates its commitment to St. Louis by providing high quality art education programs to urban youth through workshops and collaboratives with high schools & youth organizations. The Contemporary's New Art in the Neighborhood program is now in its 14th year of identifying, training, and and encouraging talented visual artists in St. Louis urban high schools. Students document their artistic efforts by creating a portfolio that can be used for employment or additional education. Forty students participated in FY2009. Contemporary ArtReach brings the Contemporary into St. Louis high schools. Students experience a year-long series of in-class docent visits and hands-on activities. In FY2009 a project with 27 students at Metro Academic Classic High School culminated in the creation of a permanent sculpture on the school campus.
