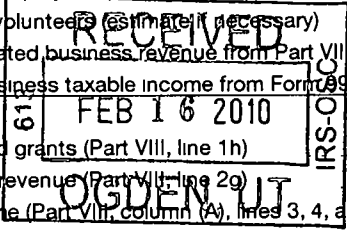

they experience. Annually, MHAP provides free legal services to over
four-thousand individuals with mental health and developmental
disabilities in Santa Clara County. This program received \$150,035 in
donated services and materials.

Legal Advocates for Children and Youth ("LACY") provides free legal
representation, advocacy, and information to approximately one-thousand
minors in Santa Clara County, and educates several hundred children,

and materials.
