PUBLIC OUTREACH/EDUCATION - In partnership with WPFW, 89.3 FM, a local public radio station, TransAfrica Forum produces a weekly show Africa Now. Each week this forum allows the organization to share news analysis, current events, and to focus on complex issues facing the African continent, Latin America, and the Caribbean with thousands of listeners. The Cabral/Truth Circle is a combination of a great film festival and an exciting book club. In 2009 the Cabral/Truth Circle series focused on a range of issues, from U.S. policy toward Haiti to the Durban Review Conference, the UN follow-up to the 2001 World Conference Against Racism.

PUBLIC AFFAIRS LATIN AMERICA/ CARIBBEAN - Our work on U.S. policy towards Haiti in 2009 addressed the role of the U.S. and international financial institutions in its political, economic and social instability, particularly with regards to organic democracy, agriculture and infrastructure, and international trade policy. TransAfrica Forum also analyzes U.S. policy towards Venezuela and develops products, forums for dialogue and delegations to support the Afro-Venezuelan civil society movement and ensure its active and central role in the Bolivarian Republic. Our work on U.S. policy towards Cuba focuses on the normalization of relations and ending the unilateral, U.S. embargo against Cuba, which has had a disproportionate impact on Afro-Cubans. TransAfrica Forum also supports the advancement of organic discourse within Cuba on issues of racial discrimination and economic and social inequality.

AFRICA POLICY - TransAfrica Forum leverages its resources and relationship building work to target specific countries in which it has civil society partners on the ground. At present, TransAfrica is working in solidarity to study and analyze new models of democratic, economic, political and social structures. TransAfrica Forum is working with our civil society allies across the African world to amplify their voices in the international policy arena and to create closer alliances between U.S. Americans, Africans, and Afro-descendants in Latin America and the Caribbean. Our work highlights the impacts of U.S. foreign policy with a primary focus on advocacy and education. For instance, in Zimbabwe, TransAfrica Forum is working to amplify the voices of civil society and Zimbabweans amidst the political turmoil, lack of representation and distortion of the realities by western and Zimbabwean media following the aftermath of the March 29 elections.
