

Blackman Jones: In 1997, parents of students with disabilities brought two class action lawsuits against D.C. Public Schools (DCPS) claiming that DCPS violated the federal law known as the Individuals with Disabilities Education Act (IDEA). In the first lawsuit, known as Blackman, parents stated that after they requested due process hearings, hearings were not held and hearing decisions were not issued on time.

In the second lawsuit, known as Jones, parents stated that once they received hearing decisions or entered into a settlement agreement with DCPS, DCPS did not provide all the services that had been ordered or agreed to. The judge put the two cases together to make one case known

District of Columbia Parent Information Network (DC PIN): Under the grant from the District of Columbia Department of Health (DOH), Community Health Administration (CHA), Advocates for Justice and Education was charged with developing the District of Columbia Parent Information Network (DC PIN). DC PIN assist children and young adults between the ages of 0-21 with special health care needs bridge the gap within the systems of care through linkage to resources, parent to parent support, individual advocacy and community education. Like other AJE programs, DC PIN is a free service to all families of the District of Columbia.

Parent Training and Information Center (PTIC): AJE provides training, information, and direct advocacy services to parents and children with special needs. Advocates assist parents in navigating through the D.C. Public School system and with understanding their rights with respect to special education. PTIC provides community education through workshops and seminars which are free to the families we serve. In addition, it is important that community based organizations serving children, youth and families understand the obligations of the public school system and the inter-relationships between the various agencies providing services to special ed children.
