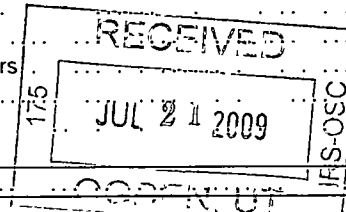

**Plan of Dissolution and Distribution**

1. We Remember Foundation, a corporation organized under the District of Columbia Nonprofit Corporation Act (the "Corporation"), will be dissolved in accordance with § 29-301.47 of the D.C. Code, 2001 Ed., and distribute its assets in accordance with the following Plan.
2. In accordance with § 29-301.49(2) of the D.C. Code, 2001 Ed., this Plan shall be adopted by a majority of the entire Board of Directors.
3. Upon adoption of this Plan, the Corporation shall cease to conduct its affairs except as is necessary for the winding up thereof.
4. Notice shall be mailed to each known creditor, if any, of the Corporation.
5. The Corporation shall collect and marshal all of its assets and apply and distribute them as provided in paragraph 6 of this Plan.
6. The assets of the Corporation shall be applied and distributed as follows:
  - a. All liabilities and obligations of the Corporation, including any fees incurred or to be incurred in connection with its dissolution, shall be paid, satisfied, and discharged, or adequate provision shall be made therefor.
  - b. All remaining assets, if any, of the Corporation, if any, shall be transferred to The Project on Transitional Democracies, a nonprofit corporation formed under the laws of the District of Columbia and exempt from tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, to be used in furtherance of the purposes for which the Corporation was formed.

**CONSENT TO ACTION TAKEN  
IN LIEU OF MEETING  
OF THE WE REMEMBER FOUNDATION**

The undersigned, being all of the directors of We Remember Foundation (the "Corporation"), acting pursuant to D.C. Code, 2001 Ed. §§29-301.47 and 2-301.99 do hereby approve, adopt and consent to the following resolutions as the acts of the Board of Directors of the Corporation:

WHEREAS, the Corporation was formed for charitable and educational purposes, and, more particularly, to "educate the public about human rights crimes and abuses in Belarus and the need for international cooperation and support to create and maintain a civil society in Belarus;" and

WHEREAS, Article SIXTH E of the Corporation's Articles of Incorporation provides that in the event of the dissolution of the Corporation, all of the remaining assets and property of the Corporation, after paying or making provision for the payment of all of the liabilities and obligations of the Corporation and necessary expenses thereof, must be distributed to an organization organized and operated for charitable and educational purposes and exempt from tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"); and

WHEREAS, the Board believes that the purposes of the Corporation can best be carried out and fulfilled if its assets and operations were transferred to the Project on Transitional Democracies, a nonprofit corporation organized under the laws of the District of Columbia and exempt from tax under Section 501(c)(3) of the Code.

NOW, THEREFORE, it is:

RESOLVED, that the Board hereby approves and authorizes the dissolution of the Corporation in accordance with § 29-301.47 of the D.C. Code, 2001 Ed.;

FURTHER RESOLVED, that the Plan of Dissolution and Distribution attached hereto be, and hereby is, approved and adopted;

FURTHER RESOLVED, that effective as of the adoption of this resolution, the Corporation shall cease to conduct its affairs except insofar as may be necessary for the winding up thereof, shall immediately cause a notice of the proposed dissolution to be mailed to each known creditor, if any, of the Corporation, and shall collect its assets and apply and distribute them in accordance with the Plan of Dissolution and Distribution; and

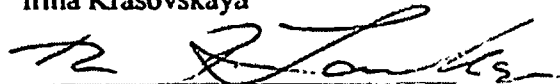
