



SPECIFICALLY, THE PROGRAM OFFERS UP TO TWO YEARS OF HOUSING FOR WOMEN AND THEIR CHILDREN WHO EXITED EMERGENCY SHELTER, ARE MAINTAINING SAFETY FROM THE ABUSER, AND ARE WORKING TOWARDS THEIR GOALS OF SELF-SUFFICIENCY. THE PROGRAM OFFERS NOT ONLY RENTAL ASSISTANCE, BUT ALSO EDUCATIONAL/JOB TRAINING FINANCIAL ASSISTANCE, UTILITY ASSISTANCE, LEGAL ADVOCACY, CASE MANAGEMENT, SUPPORT GROUPS AND REFERRALS FOR HOUSING, CHILDCARE, MENTAL/MEDICAL HEALTHCARE, TRANSPORTATION AND JOB OPPORTUNITIES.
