The Clinic provided 9008 patient visits to uninsured residents of Broward County, FL in the areas of general medicine, cardiology, dermatology, gynecology, psychology, urology and hematology. Patients were provided with free medical consults and preventative educational literature and free or low-cost laboratory testing. The Clinic has 169 volunteer staff of which 40 were licensed healthcare providers who provided a total of 5,223 hours of volunteer service. The Clinic also conducted 22 community outreach health fairs/screenings with a total of 2,425 attendees.
