	Pregnancy Services The Pregnancy Emergency Assistance and Information Referral Program provided over 100 pregnant women with crisis intervention services to address their immediate emotional and basic needs. In addition to providing information and referral for community assistance, Hope Cottage provided direct emergency assistance to assist clients with shelter, food, clothing and housing/rent/utilities. Through the Pregnancy Counseling Program we provided free, confidential, non-directive pregnancy counseling to women and birth family members to address a crisis or unplanned pregnancy, with no pressure or obligation to choose adoption. In addition, we ensured that young mothers in our parenting preparation program received parenting education, case management, emotional support, and guidance needed to help them plan for the best possible future for themselves and their babies.
