Elderhaus assists adults 18 and older with disabilities in a direct care program that offers assistance with daily living, including toileting, feeding, transportation, and supervision. Meals are served in the morning and at noon. Mentoring and counseling is offered both informally and formally to caregivers. Elderhaus is Medicaid certified, or privately paid at \$52/day or offers a sliding fee scale as needed.

Elderhaus owns five handicapped - accessible vehicles for the purposes of transporting to and from the program and coordinating activities during the day.

Many families cannot afford \$52/day and do not meet the requirements of Medicaid certification. They can apply for either a partial or a temporary full scholarship to attend the program.
