The students family makes application to the foundation by completing a need based application that provides both information about the demographics of the family but also its financial information. In addition to the application materials, current tax returns, and supporting documents, along with current pay stubs are required. A common analysis is completed on all applications with parameters of Bureau of Labor statistics being used. If analysis shows a need after the parameters are applied, an award is made. At the same time the foundation verifies with the school that it qualifies as a K thru 12 private Arizona school, and that the student that applied is a current student at the school. The grants are then approved by the foundation, and a check is sent in both the school's name and the student so that it can be applied to the students tuition. The families application, and analysis, verification of student status and check copies are maintained by the foundation.
