Production division adults with disabilities received marketable job skills training in packaging and assembly by completing production contracts in AtWork's production facility for commercial customers. Workers are paid based on productivity which allows them to maximize their potential for independence. In this fiscal year, 54 adults worked in production units where they practiced team building skills, accountability, and employment skills, preparing them for employment in community jobs

**4b** (Code ) (Expenses \$ 752,829 including grants of \$ ) (Revenue \$ 665,725 )

Group supported employment AtWork's Landscaping Division provided 9 adults with disabilities the opportunity to learn skills that would prepare them for outdoor work in the landscaping industry. They were involved in maintaining grounds for large commercial and government installations, learning how to operate landscaping equipment and meet quality standards. AtWork's Recycle Center provided 14 individuals with disabilities, valuable experience in greeting the public, following direction, and accountability and time management, thus preparing them for community employment
















**4c** (Code ) (Expenses \$ 912,361 including grants of \$ ) (Revenue \$ 1,634,049 )

Community Integrated Employment Services a discovery process identifies the abilities of individuals who have historically been excluded from working. Through volunteering, work trials, and one-on-one job coaching, each person establishes vocational goals and builds a resume that demonstrates skills needed by employers. Through outreach to businesses in King County and employer education, AtWork! works with companies to customize positions that take advantage of an individual with disabilities' unique talents while meeting a critical business need. In the fiscal year ending 2009, 20 adults with disabilities were placed in community jobs. With on the job support 47 adults retained their jobs. 90 individuals explored vocational options through volunteering, job trials and job tours. People supported by AtWork! by working in community jobs earned over \$351,000 at an average hourly wage of \$9.58
