The Foundation for Hearing Research currently has The Jean Weingarten Peninsula Oral School for the Deaf in Redwood City, CA and the CCHAT Center in Sacramento, CA where highly trained staff using special technology, such as bilateral cochlear implants, digital hearing aids, and FM systems, and advanced cognitive teaching help young deaf children reach their full potential by developing their listening and spoken language skills. The two schools function independently but share the same educational model of early intervention with newly diagnosed deaf babies and their families, and are considered models of effective early intervention in developing listening and spoken language and cognitive competencies in very young deaf children. The goal for the students who have attended these transformative programs are that they are able to be mainstreamed with their typical hearing peers by Kindergarten or First Grade. The Jean Weingarten Peninsula Oral School is also recognized as a national center of excellence for training teachers, speech therapists, and audiologists in using hearing technology (cochlear implants) with very young deaf children in order to develop listening and spoken language. Training is offered both at the school site as well as through workshops and consultation to school districts as well as colleges and universities. The Jean Weingarten Peninsula Oral School serves over 85 families in the greater Bay area as well as many more families from northern California through our collaboration with Stanford University's Pediatric Cochlear Implant Program.
