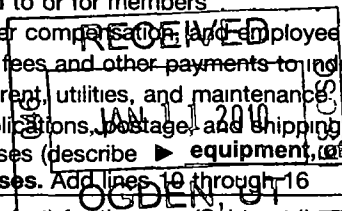

Our accounting software was changed and the tax basis switched (without our noticing it) from cash to accrual method (Quickbooks comes pre-set to the accrual method.). As a result, some of last year's financial reports were inaccurately produced using the wrong basis. We actually had \$3,659 more than the reports showed. This error was not caught until the current tax year, and so we have adjusted the "net assets or fund balances" by that amount.
