Facts And Circumstances Test
During the test period ending 2009, the Foundation received 21% of its support from the public. Based on current year's results, we believe the public percentage will continue to improve given the Foundation's fund development initiatives. These initiatives are managed by the director of development and the development associate. ZeroDivide also launched an individual donor program. The Foundation has diversified its sources of support from seven in the first year of the measurement period to over fifty in the current year. The Foundation's objective is to continue diversifying its sources of public support, both in number of donors and by donor type. By design, the Foundation's governing board is comprised of 1) individuals selected by public officials acting in their public capacity, 2) persons having special knowledge or expertise relevant to the organization's mission, and 3) community leaders. In addition to charitable grants the Foundation sponsors many programmatic initiatives supporting the public: 1) Z-Fellowships, a two-year program cultivating community-based leaders who leverage technology for the benefit of underserved populations; 2) Hip Hop, fostering a new generation of social entrepreneurs and advocates by harnessing technology and popular culture; 3) Digital Story Telling institute, supporting community based organization's use of digital media to produce and distribute original content for and about their underserved clients. In addition to the heavy annual calendar of official Foundation sponsored convenings of educators, community members and staffs of public charities, the Foundation's facilities, including the ZeroDivide Learning Lab, are available by reservation to public charities and community members. Over the measurement period, many groups use the Foundation's facilities in addition to the organization's official calendar of meetings and events.
