	White Memorial Medical Center Charitable Foundation provides a fundraising and external relations function to support the mission of White Memorial Medical Center and programs to improving the quality of life and health in our community. See the following selected information for the White Memorial Medical Center which are funded in part from the activities of the Foundation White Memorial Medical Center (WMMC) provides quality medical health care regardless of race, creed, sex, national origin, handicap, age, or ability to pay. Although reimbursement for services rendered is critical to the operation and stability of WMMC, the organization recognizes that not all individuals possess the ability to pay for essential medical services. Adventist Health's vision is to enhance the health of the communities where we live and serve, by engaging our communities and our patients in a new definition of and partnership for personal community health. In keeping with this commitment to serve all members of the community, the following will be considered when individuals who need health care cannot pay: Providing free care and/or subsidized care; Providing care to persons covered by governmental programs at below cost; Providing health/wellness activities and community education programs. Not only does WMMC provide low-cost care to individuals covered by government programs and those unable to afford health care, but it also helps patients find and access private and governmental resources for health care benefits. WMMC recognizes below-cost reimbursement as charity and uncompensated care in meeting its mission to the entire community. The unreimbursed value of providing care to these patients in 2009 was \$61,434,042. Inpatient services in 2009 were provided to 22,684 patients. These services included: 3,989 Newborns, 3,977 Babies delivered, 6,971 Surgeries performed, 1,958 Cardiac catheterizations and other procedures, 498 Skilled nursing patients, 338 Rehabilitation patients, 333 Neonatal Intensive Care Patients, 292 Pediatric Intensive Care Patients, 1,935 Psychiatric Care Patients, 2,390 Medical Services Outpatient services in 2009 were provided to 118,153 patients. These services included: 45,834 Emergency room visits, 4,118 Outpatient surgeries performed, 111,760 Radiology procedures performed, 5,950 Cardiac catheterizations and other procedures, 793,326 Laboratory tests performed, 1,849 Infant Stimulation visits, 1,158 Cleft Palate visits, 9,250 Cancer Center procedures. WMMC recognizes it has an obligation to provide human services above and beyond its role as a healing facility. The following community benefits demonstrate the tangible ways in which the organization is fulfilling its mission: Early Intervention Program, Healthy Beginnings Program, Healthy Families Program, Rainbow Center Child Care, Partners for Prevention, Parish Nursing, Health Fairs, Patient Healthcare Transportation, WMMC's Cleft Program - A Life Changing Story. Alexander, a happy 5 years old, is already a veteran of two surgeries to correct the cleft palate he was born with. When Alexander was born, his mother, Neomia Hancock, was surprised and scared. "At that time, I didn't know anything about a cleft palate - I'd never even heard of it," she said. Doctors referred her to WMMC's cleft palate program. (Cleft palate is a genetic malformation in the roof of the mouth.) "I took him there the first week of his life, and we've been going there ever since," Neomia said. "Everyone was extremely friendly and from the very beginning I felt like they treated him more like a family member than a patient. They have a group of specialists - the surgeon, dentist, therapist, nurses and others - who see him regularly. They learned our names quickly and have helped us so much." WMMC's Cleft Palate Program provides comprehensive care for children like Alexander. It is the only such program in east Los Angeles county and serves approximately 350 cleft lip and palate children each year.
