THE SCV FOOD PANTRY USES FOOD DONATIONS FROM THE COMMUNITY TO PROVIDE SUPPLEMENTAL FOOD ON A SHORT-TERM BASIS TO QUALIFIED LOCAL RESIDENTS. THE FOOD PANTRY DISTRIBUTES FOOD TO OVER 6,500 INDIVIDUALS, OF WHOM APPROXIMATELY 50% ARE CHILDREN. THE PANTRY INCREASED ITS SENIOR PROGRAM WITH FUNDING FROM A GRANT, THEREBY INCREASING THE NUMBER OF SENIOR CITIZENS SERVED. THE PANTRY RECEIVES A SIGNIFICANT AMOUNT OF DONATED SERVICES FROM UNPAID VOLUNTEERS WHO ASSIST IN PROGRAM SERVICES AND FUNDRAISING. Electronic Filing (e-file).
