Part III Statement of Program Service Accomplishments

1 Briefly describe the organization's mission

826 Valencia is a San Francisco-based nonprofit organization dedicated to supporting students ages 6 to 18 with their writing skills and to helping teachers get their students excited about writing. Our work is based on the understanding that strong writing skills are fundamental to future success and that great leaps in learning can be made when skilled tutors work one-on-one with students. During the 2009-2010 school year, we served over 6,100 Bay Area students with a variety of free literacy programs including evening and weekend writing workshops on everything from cartooning to SAT preparation, assistance with student publications including newspapers, chapbooks, and professionally bound paperbacks, customized bookmaking field trips for public school classes, in-school tutoring support on writing projects, after-school academic tutoring in all subject areas, and scholarships for college-bound students.

In-schools Program. During the 2009-10 school year, we served 49 teachers and 2105 students at 14 SFUSD schools through our In-schools Program. Students met with our volunteers over a combined total of 484 sessions throughout the year to produce myriad publications. At Everett Middle School, we served every student through our 826 Writers' Room, published two issues of the bilingual student newspaper, Straight-Up News. At our other 826 Writers' Room over at James Lick Middle School, we also served every student, and completed the second year of our video podcasting series. Our biggest publishing project was conducted at John O'Connell High School, where 50 juniors wrote about what the American Dream means to them. The students recounted stories about family, home, immigration, hardship, and the hopes of their generation as well as those of the generation that raised them. The end-product, a 258-page paperback with a foreword by author Daniel Alarcon, was celebrated with a release party on June 2, 2010 and is available for purchase on amazon.com and at bookstores nationwide.

After-school Tutoring Program. Our After-school Tutoring Program remains one of the cornerstone programs of 826 Valencia. During the 2009-10 year we hosted the program 168 days for 85 enrolled students. An additional 339 dropped-in on Sunday afternoons. Highlights of the year included two Young Writers' Wall celebrations, where we honor six students and highlight their accomplishments with full color portraits on our back wall, two issues of Look Closer/Mira de Circa, our anthology of shorter student works, the creation of two stop-motion animation films, and the start of a new partnership with the SF Chronicle where our students' movie reviews were featured prominently in the paper each month.

Field Trip Program. During the 2009-10 school year we hosted 135 field trips, up nine from the year before. During these field trips, a combined total of 3021 students from local schools visited our center in the Mission District for a morning of high-energy learning. Students interviewed local authors, practiced slam poetry, and studied journalism techniques. The most popular field trip this year was one we invented called Storytelling & Bookmaking, in which students write, illustrate, and bind their own books. Our field trip program remains so popular that our schedule is filled all the way through next year.
