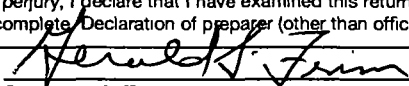
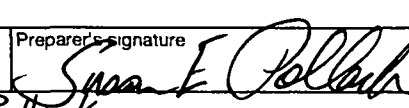

his review. Upon his approval, the Form 990 is sent to all FEJ Board members for their review. Any questions, corrections or changes are

sent to the Treasurer for his consideration. A Board meeting by conference call is held, if necessary, for any discussion. The Treasurer, in

consultation with the Form 990 preparer, then issues the final, completed Form 990 to the FEJ Board members for a last review, 10 days

prior to filing. If there are no further questions or corrections, the Form 990 is filed on time with the IRS.

Part VI, Question 12: re compliance with Conflict of Interest Policy: Prior to any vote of engaging consultants, making grants, or

purchasing any goods or services, Board members are asked if they have any personal, family, business or any other interests

that could give rise to conflict or prevent them from being impartial. Board members are asked to recuse themselves from any votes

in which they might have any possible conflict of interest.
