 Adoption Program - 337 cats and 1 dog were adopted in 2010, averaging about 28 cats per month. Cats were adopted from our Adoption Center in Harrisonburg, local PetSmart stores most weekends and in Northern Virginia every other Saturday as well as through the internet. All cats were altered, tested, vaccinated and treated for parasites prior to adoption. Many of these cats were rescued and came to us injured or ill requiring additional vetting expenditures to ready for adoption. Cats were also taken from area shelters, such as Page Animal Shelter and Augusta County SPCA. In addition 93 cats were transported to North Shore Animal League in New York City for adoption. Contributed veterinary services in the form of discounts totaled \$1,377 and contributed supplies totaled \$1,038.

4b (Code:) (Expenses \$ 64,234 including grants of \$ 0) (Revenue \$ 8,222)
 Spay/Neuter Program - 1,129 cats were altered during the year including 270 readied for adoption. In 2010, we also successfully altered 17 dogs. The program provided spay/neuter assistance to approximately 251 clients with their animals and four businesses caring for cat colonies. In addition we partnered with other rescue organizations like PAWS from Pendleton, West Virginia, and Page County Animal Shelter in Virginia. Services included transportation, trapping, and financial assistance or any combination thereof depending on the client needs. Most people provided some level of copay. Two newsletters were published in 2010 as well as three informational appeal letters to a mailing list of approximately 3,700. An eNews letter was distributed monthly to 2,000 clients and supporters. Brochures were printed and are available in many public places and are provided at community tabling events. Contributed supplies totaled \$430.
