The Journey Home provides basic needs resources such as meals, food staples, clothing, emergency (vouchers) and supportive housing, hygiene and laundry facilities and supplies, computer lab and employment readiness coaching, transportation assistance, rent and utility assistance, case management and the like to equip the homeless and disadvantaged of Rutherford County, Tennessee for self-sufficiency and reintegration into community life.

 The Journey Home provided hunger relief to the homeless and needy in the community through our Community Cafe' program. During 2010, we served breakfast and a hot lunch at our outreach center Mondays through Fridays and began serving an evening meal on Mondays only mid-year. This program provided over 30,000 meals in 2010. Additionally, the Community Cafe' program provides boxes of food staples and produce to clients in need. Over 3,800 food boxes were distributed during 2010 at our outreach center. Some of the a significant amount of the produce was raised at our community garden while other food was both purchased and received as in-kind donations. The Community Cafe' bread room also provided literally tons of bread and pastries daily that clients take with them when they leave the center. All of this is provided at no charge to the client.

4b (Code: \_\_\_\_\_) (Expenses \$ 95,390 including grants of \$ 82,186) (Revenue \$ 0)  
 The Journey Home provided housing, case management and supportive services through our Supportive Housing program. The program not only provides housing for six months to one year for clients but assistance with life skill training in areas such as budgeting, parenting, conflict management, employment readiness, living in community, and the like. We also assist clients with transportation issues, working with the school system and collaborate with other agencies to help them gain mainstream benefits. This program housed primarily families with children in 12 housing units scattered throughout the community. Ten apartments were leased and two houses were acquired through the City of Murfreesboro and HUD's Neighborhood Stabilization Program during 2010. (Revenue and expenses are not above as the purchase of the property was in the exact amount of the grant, which elevated income and fixed assets unusually this year.) Altogether, eleven families with children and seven individuals were assisted at various points of the 2010 calendar year. Seven of the households "graduated" to permanent housing during 2010.

4c (Code: \_\_\_\_\_) (Expenses \$ 43,803 including grants of \$ \$0) (Revenue \$ 0)  
 The Journey Home assisted the homeless and needy in our community with clothing, laundry, and hygiene items at our outreach center. Clients can wash up to two loads of clothes weekly and shop in our clothes closet Mondays through Fridays. While all clothing taken is tracked, there is no charge to the client for any of these services. Over 20,000 clothing items were re-distributed during 2010. Additionally, clients are supplied with toiletry items including soap, shampoo, razors, tooth care, combs, feminine hygiene, diapers and the like through this program. These are items that are difficult to budget on scarce funds and cannot be obtained with food stamps. A hot shower, proper hygiene items and clean clothes go a long way to establishing self-worth and the type of appearance that helps clients get accepted and often hired for work in the community.  
 Accounting for this program's expenses is difficult since it is a significant user of the building utilities. Expenses are estimates based on the value of the clothing and other items distributed. The organization spends a significant amount of other resources to fund this program.

**Part III. Line 2. The Journey Home expanded our supportive housing program, as described on Line 4a, significantly this year. Through the Murfreesboro HUD Continuum of Care, we collaborated with four other organizations and the city government to secure an unusual grant totaling \$254,703 from the HUD Neighborhood Stabilization Program that went directly to purchase two foreclosed properties for the specific use of supportive housing. Two families with children were served in 2010. The Journey Home also provided intake and case management services for the Homeless Prevention and Rapid Rehousing (HUD) program as a subcontractor for the Murfreesboro Housing Authority. This allowed us to serve a greater number of homeless and at-risk persons. This caused us to have to hire some temporary case managers, increasing our payroll costs. We did not report the benefits that we provided for our clients since the checks were actually prepared by MHA. We approved and coordinated \$95,292 in housing-related benefits for these clients through our office.**

**Part III. Line 4d. Other program services that were funded through our internal budget from small donors and the Emergency Shelter Grant from the City of Murfreesboro included: Case Management and Essential Services (\$7,022) including coordination of services, emergency food and clothing, medical appointments, and assistance with other housing and personal services to clients; Employment Readiness and Transportation Assistance resources (\$16,152) including GED tests, identification documents, work uniforms/shoes, bus tickets, gas vouchers and the like.**

**Part VI. Line 11. Board members are given the form 990 at the board meeting following its filing. Several board members are involved with gathering information and giving input on the form 990. Additionally, the board meets every other month and gets financial updates and reports at each meeting. The board reviews the form 990 and asks questions to verify accuracy as well as improve understanding of the way funds are used by the organization in meeting its mission.**

**Part VI. Line 19. The organization has forms on-hand at the outreach center for review by clients, donors, government representatives, etc. Form 990 is also posted on Guidestar and will be posted on GivingMatters this year. We installed a website at the end of 2010 and will be posting documents there as well when the webmaster returns from personal leave. Additionally, the organization is implementing an ID system around the first of the year. When getting a card, the clients will review and sign a new policy and code of conduct form that informs them about our documents and policies.**

**Part XI. Line 5. An error was found in the 2009 end of year reports that reduced accounts receivable to a negative (credit) balance which caused an error in the balance sheet. The correction was made causing this year's balance sheet to have to be adjusted by a small amount (\$1,672).**
