


Support and Education - TNA offers membership programs to families, individuals and medical professionals. These members are provided with access to TNA's website and various educational materials. TNA also connects patients with medical professionals that have experience in diagnosing and treating facial pain disorders and various support groups. Medical professionals, patients and families of patients are also given access to research studies, educational materials and treatment options through the conferences held by the corporation. TNA sells DVDs, CDs and other miscellaneous items to help support and promote their cause.
