 Community Services - the Community Services Block Grant (CSBG) program provides States and Indian Tribes with funds to lessen poverty in communities The funds provide a range of services and activities to assist the needs of low-income individuals including the homeless, migrants and the elderly Grant amounts are determined by a formula based on each State's and Indian Tribe's poverty population Grantees receiving funds under the CSBG program are required to provide services and activities addressing employment, education, better use of available income, housing, nutrition, emergency services and/or health Beneficiaries are low-income individuals that may be unemployed or receiving public assistance, including Temporary Assistance for Needy Families (TANF), at-risk youth, custodial and non-custodial parents, residents of public housing, persons with disabilities, persons who are homeless, and individuals transitioning from incarceration into the community The Community Action Agency of St Louis County administers these programs throughout St Louis County We have seven outreach locations to assist persons needing services Programs offered include utility assistance, food, housing assistance, youth services, counseling services, case management, weatherization, veteran assistance, water, back to school supplies and energy education In 2010, community service programs served 28,913 individuals (10,516 families)
