The Cpt. John L. Hallett III Charitable Foundation (the "Foundation") was formed to raise money and awareness for and to honor United States military servicemen and women (including the Foundation's namesake) wounded or killed in action and also to foster goodwill and provide aid to citizens in "third-world" countries; primarily Afghan families and children.

During 2010 the Cpt. John L. Hallett III Charitable Foundation successfully raised money and awareness for and to honor United States military servicemen and women wounded or killed in action through a golf tournament. This tournament raised money for the foundation and was inturn donated to two charities. The Wounded Warrior Project, which aides wounded service men and women and their families were given \$10,000. An additional \$1,000 was given to St. Agnes Catholic Church to aid citizens in Mexico and create goodwill to the citizens.
