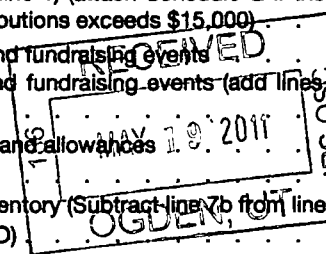

Page 2, Part III, Statement of Service Accomplishments

Defender for Children's ("DFC") vision is to improve the quality of life for children who are victims of child abuse by breaking the abuse cycle. Its mission is to create, identify and support programs designed to prevent child abuse and to improve the lives of children so they can become positive influences in our community.

In its initial short year DFC brought awareness itself and its mission by hosting events fundraising events that brought attention to the problem of child abuse including an initial kick-off party, representation in the community Christmas parade as well as other events. A website was created that provides information and educational tools including links to other organizations with overlapping goals.

DFC was very successful in a short period of time in raising awareness around the issue and gaining visibility and initial contributions. DFC expects to build on its momentum to gain enough donations to invest in additional programs, tools and materials in the upcoming year.
