FINANCIAL 2010 CONTINUED BUILDING ON THE FOUNDATION'S CORE MISSION ACCOMPLISHMENTS, IN SPITE OF THE FACT THAT FUNDRAISING REVENUES WERE DOWN FROM THE PREVIOUS YEAR SINCE THE FOUNDATION RELIES SO HEAVILY ON PRIVATE DONATIONS VERSUS CORPORATE SPONSORSHIPS, THE DOWNTURN IN THE US ECONOMY HAS HAD A SIGNIFICANT IMPACT WHILE THE LARGE NON-PROFITS CONTINUE TO TAKE IN RECORD NUMBERS, OCF IS WHAT PHILANTHROPY MAGAZINE HAS DESCRIBED AS DIFFICULT TIMES FOR THOSE ORGANIZATIONS OF SMALLER SIZE WITH A MORE FOCUSED SINGULAR DISEASE FOR WHICH THEY ADVOCATE FOR DESPITE THIS, THE DEMAND FOR THE PATIENT SUPPORT FUNCTIONS, PUBLIC FREE SCREENING PROGRAMS AND PUBLIC INFORMATION DISSEMINATION IS IN HIGHER DEMAND THAN EVER, AS THE CANCER IS ONE OF THE FEW TYPES THAT IS GROWING IN INCIDENCE RAPIDLY IN THE US THE USE OF VOLUNTEERS DRAWN FROM THE RANKS OF SURVIVORS AND THEIR FAMILIES, AND PAID CONSULTANTS AND OUTSIDE FIRMS IN WEB CONSTRUCTION, PR/PUBLIC OUTREACH, WILL HAVE TO CONTINUE RATHER THAN ADD STAFF, AS THESE COSTS CAN BE CONTROLLED MORE EASILY THROUGH OUR FINANCIAL UPS AND DOWNS OCF LOOKED TO OUR TECHNOLOGY STRENGTHS THAT ARE LOW COST TO REACH THE PUBLIC WITH INFORMATION ABOUT THE DISEASE WE HAVE RECEIVED MANY ACCOLADES OVER THE YEARS FOR OUR ABILITY TO ACCOMPLISH A GREAT DEAL THROUGH MECHANISMS THAT ARE INEXPENSIVE OR EVEN FREE IN 2010 THE STANDOUT EXAMPLE OF THIS WAS OUR QUICK RESPONSE (QR) CODE INITIATIVE THAT TOOK PLACE IN CONJUNCTION WITH THE HURLEY WORLD SURFING CHAMPIONSHIPS IN HUNTINGTON BEACH, CA, WHICH WAS ATTENDED DURING ITS TWO DAY RUN BY HALF A MILLION INDIVIDUALS USING A NEW SMART PHONE TECHNOLOGY FOR THE FIRST TIME IN THE NON-PROFIT WORLD, AND IN A MEANS WHICH IT HAD NEVER BEEN USED BEFORE, TEMPORARY BODY TATTOOS, TEAMS OF VOLUNTEERS SPREAD THROUGH THE CROWD APPLYING THE TATTOOS WHICH WHEN READ BY AN ATTENDEES SMART PHONE, WHICH TOOK THE VIEWER TO INFORMATION ABOUT THE HPV VIRUS AND HOW IT IS CAUSING ORAL CANCERS IN YOUNG, NON SMOKING ADULTS BESIDES THE 500,000 YOUNG PEOPLE IN ATTENDANCE, THE EFFORT RECEIVED NATIONAL ATTENTION FROM NUMEROUS TECHNOLOGY MEDIA VENUES, NON-PROFIT MONITORING SERVICES, AND THE GENERAL MEDIA SEE STORY HERE (HTTP //ORALCANCERFOUNDATION ORG/PRESSKIT/PDF/QR- CODE-PRESS-RELEASE PDF) THIS ENTIRE EFFORT HAD AN EXPENSE OF 4,000 FOR THE TWO DAYS OF PUBLIC AWARENESS EFFORTS WHILE FUNDING OF OUTSIDE RESEARCH HAD TO BE REDUCED, SOME IMPORTANT WORK WAS STILL ACCOMPLISHED OCF WAS A FINANCIAL CONTRIBUTOR ALONG WITH THE NATIONAL CANCER INSTITUTE, OF A BREAKTHROUGH STUDY LOOKING AT SURVIVAL RATES OF HPV+ ORAL CANCER PATIENTS COMPARED TO TOBACCO ETIOLOGY DISEASE THE OUTCOME OF THAT STUDY, DONE BY MD ANDERSON CANCER CENTER AND THE JAMES CANCER CENTER, WHICH WAS PUBLISHED IN THE PRESTIGIOUS NEW ENGLAND JOURNAL OF MEDICINE, SHOW A DISTINCT SURVIVAL ADVANTAGE FOR PATIENTS COMING FROM THIS DISEASE CAUSE THE RAMIFICATIONS OF THIS ARE THAT HPV+ PATIENTS MAY RECEIVE LOWER QUALITY OF LIFE ALTERING THE NEXT SCHEDULED DATE IMPORTANT PAPERS ON THE HPV ETIOLOGY OF ORAL CANCER AND TRANSCRIPTIONAL MEDICINE ASPECTS OF ORAL CANCER WERE DUE TO BE PRESENTED AT THIS MEETING THE INFORMATION THAT THEY CONTAINED NEEDED TO BE DISSEMINATED TO THE PRACTICING MEDICAL AND DENTAL POPULATIONS FOR IMMEDIATE APPLICATION IN THEIR REAL WORLD PRACTICES WHILE OCF WOULD NOT NORMALLY INVEST FUNDING TO UNDERWRITE A MEETING OF THIS SORT, WE FELT THAT WAITING ANOTHER FOUR YEARS TO HAVE THIS INFORMATION REVEALED WAS UNACCEPTABLE THE FOUNDATION IS CREDITED WITH MAKING THIS MEETING POSSIBLE BY THE ACADEMY OF ORAL MEDICINE, AND ALLOWING THE ASSOCIATED PAPERS ELUCIDATING THE DISEASE FURTHER TO BE PUBLISHED THE FOUNDATION EXPANDED ITS FREE PUBLIC SCREENING EFFORTS INTO 4 NEW GEOGRAPHIC AREAS WHICH HAD SIMULTANEOUS ORAL CANCER AWARENESS WALKS ASSOCIATED WITH THEM THIS YEAR THESE WERE MADE POSSIBLE BY KEY STRATEGIC RELATIONSHIPS WITH TWO DIFFERENT DENTAL HYGIENE GROUPS AND SURVIVOR VOLUNTEERS, WHO WITHOUT MAJOR COSTS TO THE FOUNDATION COORDINATED THESE EFFORTS FOR US IN 2011 THESE EVENTS WILL BE EXPANDED AGAIN THROUGH NEWLY IDENTIFIED PARTNERS, AND WE EXPECT TO HAVE 14 NATIONAL FREE SCREENING EVENTS ACCOMPANIED BY A PUBLIC AWARENESS WALK IT SHOULD BE NOTED THAT EVENTS FROM PREVIOUS YEARS CONTINUE, AND HAVE GROWN SIGNIFICANTLY IN SIZE NOW WITH SEVERAL YEARS OF EXPERIENCE AND OUTREACH UNDERSERVED COMMUNITIES THE FOUNDATION EXPANDED ITS OUTREACH TO CANCER TREATMENT FACILITIES TO PROVIDE THEIR PATIENT POPULATIONS WITH AFTER TREATMENT SUPPORT WE NOW ARE PARTNERED WITH THE MAJORITY OF THE NCI DESIGNATED CANCER CENTERS TO PROVIDE AN ONLINE SURVIVOR TO PATIENT SUPPORT GROUP TO INDIVIDUALS COMING OUT OF TREATMENTS IN ITS TENTH YEAR OF EXISTENCE, IT HAS BECOME THE WORLD'S LARGEST ORAL
