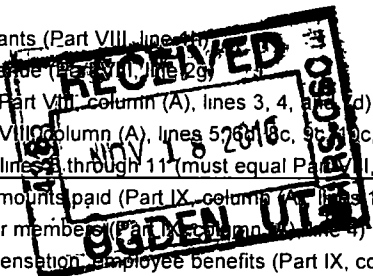

Food received from a government agency is assigned a value determined by the agency. Other food donated from the public is given a \$1 per pound value. The inventory value is offset by recording a derred revenue on the balance sheet. There is no sale of donated food.
