The Crisis Center Program (Housing and Supportive Services) provides free, accessible, bilingual and bicultural case management, housing advocacy, and job training and placement services to families, youth and single individuals who are homeless or are at risk of becoming homeless Crisis Center staff work in partnership with clients to obtain and maintain housing and employment stability Since opening its doors in July of 2002, the Crisis Center has served over 6,000 households The Crisis Center saw significant expansion in 2009 with the addition of ARRA stimulus funding for Homeless Prevention services

The Solid Ground Supportive Housing Program provides safe, stable housing for homeless male youths, aged 16 to 21 These young men can stay at Solid Ground up to two years, during which time they benefit from comprehensive case management services focusing on a holistic, strengthbased approach, as well as educational and vocational training and support The purpose of the Solid Ground Supportive Housing Program is to provide homeless and at risk youths with an opportunity to create a meaningful and positive future for themselves

The Casa Corazon Program, launched in 2009 is a homeless youth engagement initiative targeted at homeless youth aged 18-24 with a focus on Chicago's west side populations The program provides street outreach, drop in center and comprehensive case management services to youth
