During the year the Humane Animal Welfare Society of Waukesha County's Animal Rescue Team assisted 1,033 animals, of which 361 were wild creatures Over 90% of the stray dogs coming into the facility were reunited with their families The Society's Spay-Neuter Initiative Program (SNIP) continued with its excellent work by performing 2,947 surgeries, including procedures for 352 outdoor cats that were performed as part of the Society's Owned Outdoor Cat spay/neuter program The Society's spay/neuter program reduces the number of kittens and puppies born and, thus, in need of adoption Adoption numbers were down this year by fourteen less dogs, thirty-six less puppies, fifty less kittens, with seven more adult cats and three additional small animals going home The Society was chosen as the County Executive Award Winning Large Non-Profit for 2010

The Humane Animal Welfare Society of Waukesha County's Humane Education Department reached 4,449 people with its programs Teaching compassion and responsibility and providing a safe place to practice nurturing skills continues to be the focus of this department The department's program with Lad Lake and the local grade schools was popular and will be continued in fiscal year 2011 During the year many other programs were held including Kids 'N Critters Summer Day Camp, Camp "Gone to the Dogs", and Shutter Bug Camp In addition to these programs, over 500 people attended dog training classes this year
