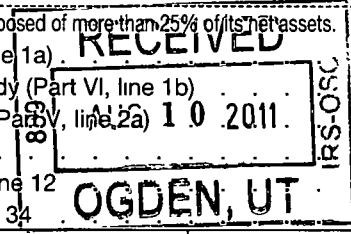

Kingdom House's mission is to help our clients break out of the poverty cycle by providing day care services, a neighborhood food pantry, employment services, elderly services and youth programs. We have been providing services since 1902.

Kingdom House Day Care Center provides child care for low income families who are working or attending school or vocational training. We provide day care for 94 children ages six weeks to six years of age. Kingdom House's infant/toddler and pre school programs have accreditation under the Missouri Voluntary Accreditation Program and is a member of the Child Day Care Association of Saint Louis which provides technical support and in-service training services. Head Start and Early Head Start programs are part of Kingdom House's Day Care program.

4b (Code:) (Expenses \$ 483,261 including grants of \$ 24,686) (Revenue \$ 568,194)

Kingdom House's Youth Programs include an After School program for ages 6 to 14 that provides tutoring, arts & crafts, computer training, sports & fitness, field trips and a meal each day after school. We also provide a seven week Summer Camp for from 150 to 175 children. During Summer Camp all kids are provided breakfast and lunch. The Sports program includes baseball, basketball, soccer and cheer leading. Kingdom House Youth Program includes a Peer Counselor program up to age 18.

Kingdom House's Core Social Services program includes a Family Center for emergency respite for up to ten children; a Food Pantry which provided food for the needy totalling 84,000 pounds for 2010; Family Support program which addresses child neglect and abuse in the Saint Louis metropolitan area. We also provide referrals to other resources in the area to help "break the cycle of poverty".
